Instructions on How to Bid

PLEASE READ CAREFULLY

- The lots described and illustrated in this catalogue are available for sale to the highest bidder. The minimum bid for each lot is the "upset price," the price listed after each description. The maximum bid is up to you. If the only bid received for the lot is the upset price, it is the highest and winning bid.
- 2 Submit your bids on one of the BID SHEETS enclosed with this catalogue. (A photocopy is acceptable.)
- 3 Enter the number of each lot you wish to bid on, and the amount of your bid, in the spaces provided.
- 4 List your bids in sequence by lot numbers A place is provided for any afterthought, out-of-sequence bids.
- 5 Keep ties at a minimum by bidding to the penny. For example, \$103.19, \$85.42, \$432.83, etc. (Many a winning bid has been only a penny or two over the underbidder.)
- 6 Note that most shipping costs, and some packing costs, are extra. (See "Key to Symbols" on opposite page.)
- 7 PRINT your name and address <u>clearly</u> on the BID SHEET.
- 8 After the deadline date, all bids will be tabulated. Those who have submitted one or more winning bids will be sent a bill by certified mail showing the total amount due. (See paragraphs 14 concerning payment.)
- 9 Shipments will be made as soon as possible, in the order in which payments are received. Please be patient. Each lot must be packed individually and with care. Lots requiring special packing will be shipped by, and at the convenience of, the professional packers.

- 10A Satisfaction is guaranteed. Unlike public auctions where everything is sold as is, and Caveat Emptor (let the buyer beware!) is the rule, every lot in this sale is guaranteed to be as described.
- 10B If you purchase and receive a lot that was not properly described in the catalogue, you will receive a complete refund of your bid (not including shipping cost) if you mail your reason for dissatisfaction within 5 days after receiving the lot. You should then wait for instructions. You may be asked to ship the lot to the underbidder.
- How to prevent overspending. First, enter the maximum amount you wish to spend in the place provided on the BID SHEET. Then, in Column A, list each lot in the order of your preference, l, 2, 3, etc. If your bid on your first preference is not the top bid for that lot, your bid on your second preference will be checked, then your third, etc. Your winning bids, if any, will be accumulated, in the order of your preference, until their total value approaches the amount you want to spend. Note that shipping charges and packing charges, if any, will be extra.
- How to get only one lot, if you want only one of several. Bid on your alternate lots. Then, in Column B, indicate your order of preference, l, 2, 3, etc. If your bid on your first preference is not the top bid for that lot, your bid on your second preference will be checked, then your third, etc. The first winning bid that shows up in your preference sequence is the only lot you will get. PLEASE NOTE: You can use this bidding method on only one group of alternate lots on one bid sheet.

- Your bids are your responsibility, so be sure to check your lot numbers and bids very carefully for possible errors. By signing the bid sheet, YOU AGREE TO TAKE EVERY LOT FOR WHICH YOURS IS THE WINNING BID. AT THE AMOUNT YOU BID.
- Payment must be made within 5 days after receipt of the bill sent to you by certified mail. If you expect to be away after the deadline for receipt of bids, be sure to make arrangements for the bill to be paid in your absence.
- 14B Participation in future CTSAs will be withheld from those who do not make payments for their winning bids within the set time limit.

- 15 A complete list of the prices paid for each lot will appear in the next available MART. Purchasers of this catalogue after the sale will find the prices paid list included.
